LCISD Ag Barn Facilities: Personal Item List for Projects

The following list of items has been developed by LCISD HS Ag instructors and the Ag Barn Manager. If you have any questions, please contact your HS Ag instructor and/or the Ag Barn Manager before bringing in your personal equipment.

All Animals –

- The District will supply each project a stall/pen and an adequate feed/supply storage area. No doubling of animal projects in one pen is permitted.
- Under no circumstances will personal items be left or stored in the aisles or common areas.
- The Ag Barn will supply brooms, shovels, wash area hoses and wheel barrows.
- Feed should be limited to no more than 200 lbs (4 50 lb bags) stored at any one time in metal containers.
- Locks may not be placed on a stall without following the district barn policies/procedures guideline (see form for details).
- Round bales are permitted in common use pastures only and must be inside a hay ring.
- Open feed bags should not be left in the barn. A metal storage container for all open feed bags is required.
- Small items such as sprays, feed supplements, fitting equipment and halters must be kept in a lockable storage container.
- The Ag Barn will provide automatic water supply for swine only.
- Show Supplies (Ask lead Ag instructor what to buy)
- Fresh/Clean Shavings (Ask lead Ag instructor what to buy)
- Electrical demands may prohibit multiple fans or heating devices from being used in a stall or area. The Ag Barn manager will determine electrical draw per project.
- Any equipment or items brought into the facility without proper approval must be removed immediately.

Poultry –

- One pen will be provided by the Ag Barn per project entry, there are no "cull bird" pens issued.
- Overhead Turbo fan will be provided by the Ag Barn.
- Personal fans may be used, following district barn facility information sheet*.
- Heat lamps should be used in the winter (Maximum 5 perpen) * LED lights are suggested to reduce heat.
- No space heaters, evaporative coolers, indoor rated power cords, plug multi ends, power cord" daisy chains" are
 permitted. Fire Code enforcement per the Fire Marshall for violations will be strictly enforced for immediate
 repair/removal.

Cattle -

- All personal items (hay, tack, feed) should remain in your area in front of your stall (Barn 1) or in feed room (Barn 2).
- Misters must be checked in by Ag Barn Manager for compliance prior to installation.
- Overhead Turbo fan will be provided by the Ag Barn.
- One personal fan may be used with Ag Barn manager authorization. No evaporative coolers may be used.

Goats, Lambs, Hogs-

- All personal items (show supplies, feed, etc.) should only be stored in the area provided by the facility. It is recommended to store personal items in a locking container and feed is required in a metal can.
- Overhead or floor fans will be provided by the Ag Barn.
- One additional small fan is permitted*; however evaporative coolers are not permitted.
- Large exercise equipment such as treadmills and wagons will be permitted only if space is available and are available for use by other students*.
